Dear Camper:

Welcome to the 2022 Oxford 250. Please note, that having a camper or tent on the property at Oxford Plains Speedway is a privilege that may be revoked at any time by Oxford Plains Speedway Management.

**CAMPER CHECK IN IS LOCATED ON THE TURN 1 SIDE OF THE SPEEDWAY PROPERTY. ALL CAMPERS MUST CHECK IN BEFORE CHOOSING THEIR SPOT(S). CAMPING SPOTS WILL BE ON A FCFS BASIS AND THERE WILL BE NO ADVANCED RESERVATIONS FOR REGULAR CAMPING SPOTS IN THE PARKING LOT AREAS**

Campers/Tents will be allowed onsite beginning Friday, August 19th, 2022 at 4 pm. Campers must be removed by Monday August 29th, 2022 at 12:00 pm (noon). **All campers/tents must be registered** with Oxford Plains Speedway and must display the Oxford Plains Speedway Camping Permit (issued at registration) at all times. Any camper/tent that is not registered or fails to display their camping pass is subject to removal by Oxford Plains Speedway Management.

**Camping costs are as follows:**

**Camping spots are available on a FCFS basis. You may purchase multiple spots. ALL personal vehicles MUST be parked within the bounds of your camping area or in the parking lot**

**Friday the 19<sup>th</sup> 4 pm-7 pm - \$125**

**Saturday the 20<sup>th</sup> through Sunday the 21<sup>st</sup> 8 am-5 pm - \$125.**

**Monday the 22<sup>nd</sup> through Wednesday the 24<sup>th</sup> 10 am-6 pm - \$100.**

**Thursday the 25<sup>th</sup> 10 am-6 pm - \$75**

**Friday the 26<sup>th</sup> – call Kevin Varney at (207) 577-1836 for availability and check-in**

**\*\*\* CAMPER's that don't fit allotted spot will be charged an additional fee**

**Any camper arriving outside of these times must check in at the registration tent at the earliest possible time.**

**Payment in CASH ONLY- Exact Change is preferable**

Below is the list of rules that must be complied with at all times during Oxford 250 week.

- Only self-contained units permitted. Tents are allowed. Hook-ups and service facilities are not available.
- All campers/tents must be parked and set up neatly and must comply with Oxford Plains Speedway Management's decisions on where and how the camper is parked. Maintenance of the area around the camper/tent is the responsibility of the owner. The camp site must be free of any and all debris such as trash, toys, and other objects that clutter the area, including any pet waste. Carry-in, carry-out and tidy up camping area before departing. Sites left in excessive disarray may be subject to a fine.
- Due to dry conditions, a decision on campfires will be made by the town of Oxford. If allowed, no excessive bon fires. Absolutely NO out of state fire wood is allowed per Maine state law.
- ABSOLUTELY NO FIREWORKS.
- All campers (adults & kids) must wear footwear at all times.
- Anyone who is fighting or doing anything that is deemed disruptive by Oxford Plains Speedway Management will lose all camping privileges and may also be suspended from the property.
- Minors **cannot** be on golf carts/ATV's/four wheelers without an adult.

The owner of the camper/tent must sign camping agreement and provide contact information to Oxford Plains Speedway.
